## **SUMMARY MINUTES**

Regular Meeting of the Board of Directors Thursday, April 4, 2024, at 5:00 p.m.

Note: Though agenda items may be considered out of order (for example, to accommodate the schedules of guest speakers and/or members of the public in attendance for a specific item, or when items are removed from the consent agenda), the official minutes remain recorded in the same order as originally published in the official agenda. Call to Order: The meeting was called to order by President Hare at 5:03 p.m. Directors
present: President Hare, Vice President Bautista, and Director Maitski. Directors McColl
and Quintero were absent (excused). Associate Directors present: Associate Directors
Rick Lanman and Bill Leikam. Executive staff present: Executive Director/District Clerk
Moreno.

#### 2. Meeting Agenda

Motion: Approve the agenda as presented. (Maitski/Bautista; 3-0-0; McColl and Quintero absent)

- **3. Public Comment:** President Hare asked Associate Director Bill Leikam if he would like to give a report under Public Comment since he is scheduled to leave the meeting early, so he reported that he is working to have the gray fox removed from the list of authorized animals that may be hunted in California.
- **4. Consent Agenda:** Item 4.1 will be continued to the next meeting to provide additional time for Director review.

Motion: Approve the consent agenda as amended. (Maitski/Bautista; 3-0-0; McColl and Quintero absent)

#### 5. Partner Reports

- 5.1 *USDA-NRCS:* District Conservationist James Booth was unable to attend the meeting.
- 5.2 Other Partners: Genevieve Yip, Senior Management Analyst, Valley Water Office of Government Relations, reported that they have launched their 2024 Water Conservation campaign and have an outreach toolkit available on their website. Rosario Torres, Director of Tamien Nation Cultural Fire Program, announced that they have recently received two grants to advance their work.

#### 6. Administration

6.1 Director Appointment: President Hare reported that Santa Clara County has responded to the notice provided to them of Director McColl's intended resignation. They indicated that since it is an unexpected vacancy, the NSCRCD Board has the authority to make the appointment for the remainder of Director McColl's term, so she has asked Executive Director Moreno to begin the recruitment. Candidates would be brought forward to the Board for consideration under a process to be determined by the Board. Associate Director Rick Lanman indicated he will be submitting a letter of

In response to Director Bautista's question regarding development of a recruitment process, Executive Director Moreno reported that the District already has a robust recruitment process in place; applicants will be screened for eligibility pursuant to the minimum requirements of Division 9 and referred to the Board for consideration. She also reported that the District has already received two applications for the vacancy, which takes effect on April 5, 2024.

Motion: Create an ad hoc committee to develop objective criteria for evaluating candidates for the open Director position. (Bautista/Maitski; 3-0-0; McColl and Quintero absent)

Vice President Bautista and Director Maitski were subsequently appointed to the ad hoc committee by consensus.

- 6.2 California Association of Resource Conservation Districts (CARCD):
  - 6.2.1 *Elections:* Executive Director recommended the Board authorize Director and CARCD Delegate Maitski to vote for Peter Van Dyke for Vice President and John James for Secretary-Treasurer.

Motion: Select Peter Van Dyke as the choice for Vice President and John James as the choice for Secretary-Treasurer for CARCD. (Maitski/Hare; 3-0-0; McColl and Quintero absent)

- 6.2.2 *Special Membership Meeting:* Executive Director Moreno gave an update on the request submitted to CARCD for a special membership meeting by the five RCDs. Director Maitski reported on his work so far as a member of the CARCD Bylaws Committee.
- 6.2.3 *Member Records:* Executive Director Moreno gave an update on the formal records request submitted to CARCD by the five RCDs.
- 6.3 NSCRCD-SBRCD MOU: NRCS is encouraging the District to have a Memorandum of Understanding (MOU) in place with San Benito Resource Conservation District (SBRCD) in order to formalize the RCDs' mutual initiative to collaborate on agricultural programs, watershed restoration and enhancement projects, community outreach, and public education, including but not limited to the sharing of resources for the NSCRCD Farm and Ranch Resilience Program, which has been funded by a USDA-NRCS historically underserved producer cooperative agreement.

Motion: Approve the MOU between the two RCDs as written (Hare/Bautista; 3-0-0; McColl and Quintero absent)

6.4 Executive Director Report: Executive Director Moreno reported she is working with the Farm and Ranch Conservation Program Coordinator on extending work eligibility in order to be able to have them continue in their current assignment.

# 7. Programs and Projects

- 7.1 Farm & Ranch Resilience Program: Executive Director Moreno reported the program's community engagement plan is in the process of being finalized after review by NRCS. The District will be hosting a series of workshops for Chinese growers based on the resource priorities the growers identified during the Local Work Group meeting. She also said it would be nice if individual Directors could take turns attending the workshops to introduce themselves to attendees.
- 7.2 Executive Director Report: Executive Director Moreno reported that Conservation Program Coordinator Andrew Lopez was invited to present on Integrated Pest Management at a workshop hosted by the Santa Clara Valley Urban Runoff Pollution Prevention Program (SCVURPPP) for municipal employees. President Hare asked Seth Schalet, CEO for Santa Clara County FireSafe Council, if he had anything to report. He referred to the planned joint collaboration with the District on the PSA for the Los Gatos Creek Watershed Collaborative Forest Health Project.

- 8. Board Member, Associate Director and Committee Reports: President Hare reported on her attendance at a California Special Districts Association (CSDA) arranged meeting with Congresswoman Zoe Lofgren. Vice President Bautista asked for and received an update on the logo contest. Associate Director Lanman reported that he had been in contact with Cal Trans regarding fencing to protect wildlife attempting to cross Highway 101 in Coyote Valley, and they are open to a meeting to discuss. He has had a paper accepted for publication on the historic presence of elk in the Sierra Nevada, and is continuing work on the redwood suitability analysis publication. President Hare asked for an update on the Chinook salmon range after the aDNA study, and Associate Director Lanman responded that National Oceanic and Atmospheric Administration (NOAA Fisheries) has accepted that Chinook salmon are historic to the South Bay tributaries, but he said relevant maps have not yet been updated.
